SEPTEMBER 8, 2005

Chairman Rick Proctor presided. Roll call showed Vice Chairman Alexander Mirabella, Freeholder Angel G. Estrada, Freeholder Chester Holmes, Freeholder Bette Jane Kowalski, Freeholder Adrian O. Mapp, Freeholder Deborah P. Scanlon, Freeholder Daniel P. Sullivan and Freeholder Nancy Ward in attendance.

Also present were County Manager George Devanney, County Counsel Robert Barry and Clerk of the Board Nicole L. Tedeschi.

PRAYER AND SALUTE TO THE FLAG were led by the Clerk of the Board.

OPEN PUBLIC MEETINGS ACT was read by the Clerk of the Board.

MOMENT OF SILENCE for the victims of Hurricane Katrina which struck New Orleans, Louisiana, parts of Mississippi and parts of Alabama last week.

The Chairman stated that Vice Chairman Mirabella had a Resolution to present. The Vice Chairman presented a Resolution to Sean Carr of the Office of Public Information in recognition for his contributions as a journalist, public relations specialist and writer to that department over the years, as he goes into a new job in Washington, DC. Mr. Carr made remarks thanking the Board.

The Chairman said that on Friday, September 16, the County will hold its annual POW/MIA Remembrance Day on the Courthouse steps. The Chairman called Mr. John Gratacos, State Sergeant-at-Arms of the Vietnam Veterans of America, forward to make an announcement. Mr. Gratacos said that ground will be broken for a memorial for the Vietnam veterans from Elizabeth on September 16th at 2:00. He thanked the Board for its support of this memorial that has been five years in the making.

Freeholder Estrada asked a question regarding funding for item # 1, a bicycle path in Union County. Director Daley said that he would clarify the funding plan.

- 3. Extending the contract with **Development Directions, LLC, Rahway, NJ,** for the administration of the Multi-Jurisdictional Rehabilitation Program (MJHR) and the Union County Lead Environmental Analysis Assistance and Reduction Program (UCLEAAR) for four (4) months from September 1, 2005 December 31, 2005. III. DEPARTMENT OF ENGINEERING & PUBLIC WORKS Frank Dann, Director

Director Dann stated that there would be an additional Resolution for a banner to be hung advertising the Kiwanis Club Pancake Breakfast for the next meeting.

Freeholder Estrada asked what the problem is with the lake in item #3. Once the State got involved they had some comments on some further work to be done. He said he would get back to the Freeholder on the details on the work.

3. Awarding a professional engineering service contract to **O'Brien & Gere Engineers, Inc., Edison, New Jersey,** for the redesign of Nomehegan Lake Dam in an amount not to exceed **\$14,000.** (**CH. PROCTOR**)

Freeholder Ward asked if funding needed to be approved as well as the agreement in item #4. Director Dann said that funding did not need to be approved, there is funding already set for this project. Vice Chairman Mirabella asked to see a complete breakdown of funds for this item even though the funding is not an issue in this resolution.

- 4. Authorizing an Inter-local Agreement with the **Township of Cranford** for the purpose of providing funding for the construction of Transportation Infrastructure Improvements along Centennial Avenue, County Route 615, Cranford, New Jersey. (**CH. PROCTOR**)
- 5. Concurring with the **City of Linden** amending a Resolution designating Bus Stops along East Elizabeth Avenue, northbound, on the easterly side, a Union County Road, and along East Elizabeth Avenue, southbound, on the westerly side, a Union County Road. **(CH. PROCTOR)**

6. Freeholder Estrada asked for details on the changes in the project necessitating the increased cost in item #7. Director Dann responded that the project started 5 years ago and technology has changed, requiring the wiring and computer plans to be changed. Also the old building on the site had to be stabilized with steel at a large cost due to the increased price of steel. In addition, he said, the D.O.T. also held up the project with permit delays.

Freeholder Mapp also asked questions on item #7 regarding the total cost including any other change orders for the project. Director Dann answered his questions regarding these earlier change orders.

Freeholder Ward asked if the County had a contract with a structural subconsultant who was mentioned in a memo. Director Dann said the Architect had contracted with that consultant. Director Dann introduced Joe Paternoster, of the Division of Engineering, who answered Freeholder Ward's questions in further detail.

Freeholder Ward asked for further cost breakdowns, which Mr. Paternoster outlined.

7. Approving Change Order No. 8 to the contract with Paley Construction Company, Springfield, New Jersey, for general condition costs incurred due to a one month delay for contract execution in underpinning issues; in addition to three months added time due to untimely steel shop drawing reviews and approvals; structural modifications for additional steel and detailing; temporary building heat due to late start and D.O.T Permit delay for gas utility work; as well as meter set work by utility in the amount of \$90,445.53 for a new contract amount of \$3,399,576.42. (CH. PROCTOR)

IV. DEPARTMENT OF FINANCE Lawrence Caroselli, Director

RESOLUTIONS

Freeholder Estrada asked if item #2 is a yearly grant from the state. Director Caroselli said that it is annual and this is a renewal. He deferred to Chief Vaniska who is the 911-coordinator for the County. Chief Vaniska commented further on the 911 funding, noting that this grant offsets costs for educational materials, meetings and seminars and is given to the County to be distributed for the benefit of the towns. He also commented on enhancements to the 911 program.

V. DEPARTMENT OF HUMAN SERVICES Frank Guzzo, Director

Director Guzzo stated that there will be one more Resolution for next week, a laudatory for Sandy Ehrwin, the Education Director for the Union Way of Union County, who is retiring and leaving the County.

Director Guzzo also talked about the enrollment plan for the Discount Prescription Program and noted that the cost of enrollment is going down this year. He stated there are 8,971 card members as of now, which works out to being 22,000 people, one card per household. He said the average savings for the enrollment is 0 to 33%.

RESOLUTIONS

- 1. Authorizing the County Manager to enter into an agreement with **Trinitas Hospital**, **Elizabeth**, **New Jersey**, for the purpose of providing Inpatient/Outpatient and Emergency Room services to UC Jail inmates and Juvenile Detention detainees for the contract period of October 1, 2005 December 31, 2007 in an amount not to exceed \$250,000 in 2005. {Local funding: \$250,000} (FR. ESTRADA)
- 2. Amending **Resolution No. 558-2005** between the **Mercer County Board of Social Services** and the County of Union in order to accept an additional \$40,871 to provide intensive case management services to TANF families receiving public assistance through the Supplemental Assistance to individuals and Families (SAIF) program from October 1, 2004 September 30, 2005 increasing the contract amount to \$141,125. {State funding: \$40,871; Total funding: \$141,125} (FR. Freeholder Estrada said he just wanted to highlight this Resolution that he had been working on for some time.

- 3. Authorizing the submission of the 2006-2008 Youth Services Commission Comprehensive Plan and Application to the Juvenile Justice Commission. (FR. ESTRADA)
- 4. Amending **Resolution No. 1150-2004** between the County of Union and **Immaculate Conception Church, Elizabeth, New Jersey,** to provide an additional 25 parking spaces at a monthly cost of \$1,000 for the contract period of September 1, 2005 December 31, 2005. This will bring the total number of parking spaces to 75 and the new monthly cost will be \$3,000 (from 50 parking spaces at \$2,000 a month to 75 parking spaces at \$3,000, changing the annual amount from \$24,000 \$28,000 for the four months remaining in the contract).

{State funding: \$14,000; Local funding: \$14,000; Total funding: \$28,000} (FR. ESTRADA)

VI. DEPARTMENT OF PARKS, RECREATION & FACILITIES Charles Sigmund, Director

Freeholder Sullivan asked about the temporary cooling system for Warinanco Ice Skating Center, wondering how much longer it would be before a permanent system would be installed. Director Sigmund discussed where the planning and design for the cooling system and other renovations stands for this year. He stated that the County will be renting a cooling system for one more year before the permanent system will be completed. He also discussed the planning and design process in detail and proposed renovations.

RESOLUTIONS

- 1. Authorizing the County Manager to enter into an agreement with **Resurfix, Inc., Flanders, New Jersey,** to provide technical consultation, inspection and preventive maintenance of the two (2) Zamboni Ice Resurfacers at the Warinanco Skate Center in an amount not to exceed \$4,900. (FR. KOWALSKI)
- 2. Authorizing the County Manager to apply for and accept \$14,000 awarded through a New Jersey Tree Foundation "Second Cities Initiative" Grant. A \$14,000 County in-kind match, as required by the grant, is also requested. The funds would allow for the development of a Union County supplement plan to add to the existing Community Forestry Management Plan and enable the County to implement a tree planting project that would generate community support and involvement in urban forestry. The grant would provide technical assistance, training for staff and other resources. {New Jersey Tree Foundation: \$14,000; County: In-Kind Services Match: \$14,000; Total funding: \$28,000} (FR. KOWALSKI)
- 3. Authorizing the County Manager to enter into a professional architectural engineering service contract with **The Musial Group, Mountainside, New Jersey,** for the purpose of providing services as the County's Architect of Record. These services are for minor renovation projects or space planning projects on an as needed basis for a two (2) year period commencing September 1, 2005 September 1, 2007 in an amount not to exceed **\$100,000.** (**FR. KOWALSKI**)

VII. DEPARTMENT OF PUBLIC SAFETY Harold Gibson, Director

RESOLUTIONS

1. Authorizing an exception to the purchasing law allowable under NJSA 40A11-5:1dd for the purchase of propriety computer software and hardware upgrades" for the **Countywide Fire Mutual Aide Computer Assisted Dispatch System** purchased under the Union County Homeland Security Grant Program in an amount of \$250,000. {State funding: \$250,000} (CH. PROCTOR)

Freeholder Estrada asked why the department could find no pathologist in NJ for the position. Director Gibson replied that there are not a lot of pathologists in NJ, many of them work for more than one county.

2. Amending Resolution No. 1240-2004 replacing Dr. Albert Wayne Williams, Montclair, New Jersey with Dr. Joann Habermann, New York, New York, as a forensic pathologist to perform autopsies and/or external examinations during weekends at a rate of \$600 per autopsy; \$100 per external examination; \$325 per 24 hours on-call and \$700 per court appearance. {There is a remaining balance of \$16,000 which will not be exceeded} (CH. PROCTOR)

Freeholder Estrada asked if the Medical Reserve Corps project would cost more than the \$25,000 in item #3. Director Gibson said this amount is the part the County must put forth now toward starting this Corps. Chairman Proctor also answered the question, noting that this is a grant and just for initiating the program for the first year.

3. Entering into an agreement with the **Union County Alliance** for the purpose of starting the Union County Medical Reserve Corps., for Union County in an amount of \$25,000. {State funding: \$25,000} (CH. PROCTOR)

Freeholder Ward asked why the money in item #4 is from a grant from Human Services when it appears to be going to Homeland security. She questioned why it was not Homeland Security money. Chairman Proctor answered that it is CDC money from the state and that the State health department handles it.

4. To accept and adopt the **New Jersey Department of Health & Senior Services Grant 06-1165-BT-L-3** to fund the development and coordination of Bioterrorism Preparedness within Union County through the LINCS for the contract period of August 31, 2005 – August 30, 2006 in an amount of \$538,133. (CH. PROCTOR)

VIII. RUNNELLS SPECIALIZED HOSPITAL Joseph Sharp, Director

Director Sharp commented on a recent fund raising event held for the benefit of Runnells Specialized Hospital, thanking the employees of the Parks and Recreation Department who helped to make the event a big success. County Manager Devanney also commented on the fund raising event and commended Director Sharp on its success.

- 1. Renewing the contract with **Harish K. Tzeng, MD, Associates in Rehabilitation Medicine, Morristown, New Jersey, to provide professional physiatry services to the patients/residents of Runnells Specialized Hospital for the contract period of October 1, 2005 September 30, 2006. {This is a Fee for Service Agreement, At No Cost to the County} (FR. KOWALSKI)
- 3. Renewing the contract with **Ostap Tershakovec, DDS, Westfield, New Jersey,** to provide professional dental services to the patients/residents of Runnells Specialized Hospital for the contract period of October 1, 2005 September 30, 2006. **{This is a Fee for Service Agreement, at No Cost to the County} (FR. KOWALSKI)**

Freeholder Scanlon asked what Hyperalimentation is. Director Sharp stated that it involves working with feeding tubes. He also said that offering this service to patients and residents can also be revenue producing. He stated that the man chosen is an expert in this area.

4. Entering into a contract with **Kenneth Storch**, **MD**, **Florham Park**, **New Jersey**, to serve as the Director of Metabolic Services and Hyperalimentation to the patients/residents of Runnells Specialized Hospital for the contract period of September 1, 2005 – August 31, 2006 in an amount of **\$12,000**. (**FR. KOWALSKI**)

Freeholder Scanlon asked what the daily rate was prior to the change in item #5. The Director responded that it was \$355. He stated that services in this department have a much higher staffing level than other areas of the hospital. Director Sharp also outlined how the patients pay the fees through their insurance.

- 5. Requesting to change the **Private Rate for the Sub Acute Unit (1 West Sub Acute)** to a daily rate of \$375 a day. (FR. KOWALSKI)
- 6. Amending **Resolution No. 428-2005** to the contract with **Grainger Industrial Supply, Lake Forest, IL**, to purchase materials needed to repair equipment for the contract period of March 1, 2005 February 28, 2006 in an additional amount of \$1,500 for a new total contact amount of \$33,200. (FR. KOWALSKI)
- 7. Amending **Resolution No. 124-2005** to the contract with **Welco-CGI Gas Technologies** through NJHA Group Purchasing for the purchase of portable oxygen and related products for the contract period of January 1, 2005 December 31, 2005 in an additional amount of \$3,000 for a new total contract amount of \$23,000. IX. OFFICE OF THE COUNTY CLERK Joanne Rajoppi

Clerk of the Board Nicole Tedeschi responded to questions for the Office of the County Clerk. Vice Chairman Mirabella asked about the contract period. The Clerk of the Board said that she would inquire as to why the contract extension was for so long and goes back to April and will get a response for the Vice Chairman.

X. OFFICE OF THE PROSECUTOR Theodore J. Romankow

Albert Cernadas, Jr., First Assistant Prosecutor, represented the Office of the Prosecutor.
