Also present were County Manager George Devanney, County Counsel Robert Barry and Clerk of the Board Nicole L. Tedeschi.

**ORDINANCE NO. 623-2006**

**AN ORDINANCE SETTING FEES FOR UNION  
COUNTY PARK FACILITIES FOR THE YEAR  
2006**

**BE IT ORDAINED** by the Board of Chosen Freeholders of the County of Union as follows:

1. That the schedule of fees attached hereto are hereby adopted as the official fees for the use of all County Park Facilities.
2. That this Ordinance shall take effect at the time and manner provided by law.
3. That the Clerk of the Board be and is hereby authorized and directed to publish the required notice in the appropriate newspaper of such introduction and of a public hearing on February 16, 2006 and shall forward one certified copy, upon final passage, to each Clerk of all Municipalities located within the County of Union.
4. That the plans pertinent to this Ordinance are on file in the Clerk of the Board's Office.

**MEETING OPEN TO THE PUBLIC FOR THE  
PURPOSE OF COMMENTING ON  
RESOLUTIONS ON THE AGENDA ONLY**

Jerry Goldman, Kipling Rd., Elizabeth, offered congratulations to the re-elected Freeholders, Estrada, Proctor and Ward. He then requested a copy of Ordinance 623-2006 and was referred to the Clerk of the Board.

Susan Jaffee, a member of a group called FOCUS for the visually impaired spoke to the Board regarding an issue with the Paratransit service. Her group is requesting to be allowed to book the service to transport members to a regular evening meeting. This service had been suspended due to various concerns. The Chairman referred her to Frank Guzzo, Director of Human Services, who spoke with her outside of the meeting to address the issues.

Bruce Patterson, Willow Ave., Garwood, offered congratulations to the Chairman. He then commented that the Agenda for tonight's meeting was handed out too late for him to peruse, and requested that if the agenda is late in being produced that the meeting be delayed for five minutes to allow the public to read the Agenda. Chairman Mirabella apologized for the delay in getting out tonight's agenda, explaining that there had been a last minute change.

Donna Bolle, Elizabeth, commented on an incident that occurred today during a Paratransit ride, in which a handicapped passenger had fallen. She asked the managers of the service if they could reinforce to the drivers the importance of making sure that passengers are properly secured. The Chairman referred her to Frank Guzzo, the Director of the Human Services Department, who stated that he would look into the incident.

Jerry Goldman, Kipling Rd., Elizabeth, commented on an article in which he read of the purchase of some land in the City of Summit for \$4 million dollars, with a \$3 million contribution from the County. He asked who owned the property. The Chairman responded that the County will own the property and keep it as open space.
