**Re: BioBlitz**

The Chairman called upon Vice Chair Kowalski to introduce the Bio Blitz presentation. Vice Chair Kowalski made remarks regarding the good work of the Rahway River Association in conjunction with the Union County Parks and Recreation staff. Dennis Miranda of the Rahway River Association presented a Power Point presentation on the goals of a Bio Blitz program. Bio Blitz is cataloging and showing biodiversity in the parks system of Union County as well as providing an ecological survey on the area by scientist. The Bio Blitz program raises awareness of the importance of the open space and parks as ecosystems and outdoor classrooms. Bio Blitz was held last year at Lenape Park with touches upon five different municipalities. Over six hundred and sixty species of plants and animals were found and cataloged in a twenty-four hour period. The program is met with a great deal of enthusiasm from its volunteers. Volunteers include naturalists, scientists, people from academia and people from the various towns of Union County were all included. This years Bio Blitz project will be held at Ashbrook Park in Scotch Plains.

Chairman Mirabella thanked the Bio Blitz participants and organizers. He made mention of the Vice Chair's report to the Board and how she was very impressed. The Chairman asked if any other Counties run programs of this kind. Dennis Miranda of the Rahway River Association said

that Camden and Bergen Counties were planning projects. Mr. Miranda believes that this is a great way to study parks and wildlife in its own element.

Freeholder Estrada asked what might happen if others species were introduced to the park from outside that particular park system. Mr. Miranda stated that they have put in Blue Bird Houses to increase the Blue Birds into the park system. Freeholder Mapp asked if there were evasive plants found in Lenape Park during the project.

Mr. Miranda said that Japanese Mountain Weed was growing there. The trees that are indigenous to the area are having a difficult time with some of these more evasive plants. Betty Ann Kelly mentioned that Parks and Recreation was finding ways to addressing these problems successfully. The Blue Bird program was very successful in bringing the Blue Birds back to that area.

Chairman Mirabella thanked Mr. Miranda and the staff of Parks and Recreation including Betty Ann Kelly and Liz Crawford for their participation in programs of this kind. Chairman Mirabella made special mention of the concise manner and information supplied to the Board introducing this topic to them. The Chairman gave Mr. Miranda the highest accolades for his presentation. Betty Ann Kelly of Parks and Recreation made one more mention of the dates for the Bio Blitz project at Ashbrook Park in Scotch Plains – June 23<sup>rd</sup> and June 24<sup>th</sup>, 2006.
