Also present were County Manager George Devanney, County Counsel Robert Barry and Clerk of the Board Nicole DiRado. Freeholder Daniel P. Sullivan was absent.

### **PRESENTATION:**

### Sevell Farm Public Advisory Committee Mayor Martin L. Marks

Presenting in regards to the Sevell Farm property was: Jeff Bottger and Ed Klump, T&M, William McGloin, Sterling Chase resident and Board Member; Phil Melville, Cooper Road resident; Tom Paterson, Baseball official, Scotch Plains resident; Ed Zazzali, Chairman, Recreation Commission, Scotch Plains resident. Absent from the presentation was Linda Cassidy, Sterling Chase resident who's property abuts the Sevell property and Tom DiGiacomo, Soccer official, Fanwood resident. Letters from Ms. Cassidy and Mr. DiGiacomo were given to the Clerk. Each member of the committee and the two members of T&M spoke to the Board about their ideas and planned use for the Sevell property. Most agreed that it should be a mixed-use recreational area with at least one playing field, and some passive outdoor space. Each member gave a full and detailed discussion for the utilization of the Sevell property.

Mayor Martin Marks of Scotch Plains spoke of his enthusiasm for the use of the Sevell property as a recreational area and thanked the Board of Freeholders for all the work that Scotch Plains and the County have done successfully in the past. Mayor Marks added that he would like to see the Sevell property as a mixed use recreational park area for Scotch Plains and Union County, and added that the main residence currently on the property could be used

for a possible Senior Center or housing of maintenance equipment. The Mayor also expressed his appreciation to the Trust Fund Advisory Board members and Vicky Durbin Drake, Open Space Administrator, and Michael Brennan, Deputy Trust Fund, as well as T&M for their commitment to working out the differences for the use of the property. Mayor Marks remarked that if the former Sevell house was to be used as a senior center that Scotch Plains would be pleased to make a significant financial contribution. Mayor Marks also committed to having Scotch Plains maintain the property.

Chairman Mirabella thanked everyone for coming together on this project meeting and keeping everyone informed. The Chairman thanked Vicky Durbin Drake for her commitment to the Sevell property. Chairman Mirabella stated that he'd like to have further discussions with the Mayor and about the specifics of the project, and asked everyone to keep in mind this is a County Park and while comments from Scotch Plains residents will be considered the final decision will be based on what is best for the County as a whole.

Freeholder Deborah Scanlon thanked the group for presenting the Board with creative fresh ideas for the Sevell property. Freeholder Scanlon thanked Vicky Durbin Drake for her work and dedication.

Freeholder Estrada noted that a park in Scotch Plains would greatly add to the already broad and well used recreation facilities Union County offers.

Freeholder Mapp stated that he felt it was a result of open and good communication that this group was able to achieve so many good ideas. Freeholder Mapp thanked Mayor Marks for his work with the County.

County Manager George Devanney asked T&M for an approximate timeline. Jeff Bottger of T&M believed that it would take approximately seven months to design and then approximately one season to construct. County Manager Devanney asked if it would be possible to have this project go out to bid in the Spring? Mr. Bottger stated that he felt it was possible. The field will possibly be ready for use in 2008.

# I. DEPARTMENT OF ADMINISTRATIVE SERVICES M. Elizabeth Genievich, Deputy County Manager/Dir. of Administrative Services

Mike Yuska, Director of Purchasing represented the department.

Mr. Yuska stated that he would like to add two bid awards associated with the PARIS grant for the upcoming meeting.

### **RESOLUTIONS**

1. Amending **Resolution No. 858-2005** to the contract with **PMK Group, Cranford, New Jersey,** to provide Health and Safety Compliance Services for the County of Union for the contract period of June 30, 2006 – July 21, 2006 in an additional amount of \$3,727.57 for a total contract amount not to exceed \$118,727.57 which includes the following services: Attendance of Executive Safety & Labor Safety Committee Meetings; Compilation of Safety Meeting Minutes; Training of County employees; and Meetings/Research regarding questions and concerns of County personnel. Freeholder Mapp and what does PMK do for the Safety Committee asked if the dates were accurate on the Resolution and would only apply for a month, County Manager Devanney believed that this was an extension to an already existent contract. PMK attends all monthly safety committee meetings, and works with the County of issues relative to POSHA, workers' compensation, and safety training. This contract was awarded through a fair and open process.

- 2. Authorizing the County Manager to award the proposed contracts obtained through advertised public bidding in accordance with Local Public Contracts Law 40A:11-1 et seq: (CH. MIRABELLA)
  - a. <u>DIVISION OF FACILITIES MANAGEMENT:</u> Waste Management of New Jersey, Inc., Elizabeth, New Jersey, to provide waste compactor and dumpster services for various location in Union County in an amount of \$150,000.
  - b. <u>DEPARTMENT OF ENGINEERING & PUBLIC WORKS:</u> International Salt, Clarks Summit, Pennsylvania, to provide rock salt for a period of twelve (12) months in an amount not to exceed \$332,000.
  - c. <u>DEPARTMENT OF ENGINEERING & PUBLIC WORKS:</u> Marbro, Montclair, New Jersey, for the replacement of Farragut Road Bridge over Green Brook, Plainfield, New Jersey, in an amount of \$1,917,117.

Freeholder Mapp asked if there was any contribution coming from Somerset County? Mr. Timoth Mettlen, of Engineering, stated that there was an agreement with Somerset County essentially dividing the bridges at Somerset Avenue. Somerset County maintains the bridges West of Somerset Avenue and Union County maintains the bridges East. Freeholder Mapp asked when construction would begin. Mr. Mettlen stated that he believed work would beginning in approximately six weeks.

d. <u>DEPARTMENT OF ENGINEERING & PUBLIC WORKS:</u> Longo Inc., Ramsey, New Jersey, to replace auditorium seating at Trailside Nature & Science Center in an amount of \$34,719.

- e. <u>DIVISION OF DATA PROCESSING & TELECOMMUNICATIONS:</u> Millennium Communications Group Inc., East Hanover, New Jersey, to provide data and voice cabling installation services in an amount of \$155,000.
- 3. Amending **Resolution No. 2006-650** the Prescription Plan (Self Insured) to include the **Early Retirement Incentive Prescription Drug Component** with **Systemed** (**Medco**). Director Faella said that there was approximately 26% less coming in this year from Workforce Investment funding leaving the County approximately one million dollars less than last year. Director Faella worked to minimize the effects of this cut and allocated administrative work among employees so more money would be put into services.
