
I have been retained by Mr. and Mrs. George Devanney to represent them with respect to some of the content posted on your website, The County Watchers.

I am requesting that you immediately remove pictures of the Devanneys' private residence. The Devanneys have 4 school age children, one of which is three months old. Posting pictures of their home is not only an invasion of their privacy but also puts their entire family at risk because Mr. Devanney has dealt with many disgruntled employees in his capacity of County Manager. Posting comments about his family and publishing photos of his private residence run afoul of being a watchdog and into the realm of a personal vendetta.

Additionally, your website has made unfair references to Angela Devanney, George's wife. As such, I am requesting that you remove any and all references to her because she is neither a public employee nor a public official.

Mr. Devanney in his role as Union County Manager is a public figure, however some of your postings are factually incorrect and others attack his personal life. Comments about Mr. Devanney outside the scope of his public employment are inappropriate and libelous. Finally, taking pictures of Mr. Devanney outside his gym and following him from Garwood to Berkeley Heights in the early morning hours serves no purpose for your watchdog activities and borders on criminal conduct.
